

# Sexual Assault Lawsuits

When a woman is the victim of a sexual assault, she may choose to press charges against the alleged attacker. Some victims of domestic violence also wish to have their attacker press criminal charges against them in order to receive justice. The criminal justice system in most states starts with the victim reporting the crime to police and then the prosecutor will decide if there is sufficient evidence to proceed with a criminal case against the suspect. If the suspect does in fact face a criminal case, his or her bail will be set by the court and they will be held in jail awaiting trial. Although it's rare, some cases do end with the defendant being acquitted or having a lesser charge.

Although most prosecutors handle sexual assault cases, not all of them handle them. Many rapes occur at the home rather than in public places. In such instances, victims may contact the local county prosecutor's office instead of contacting the state or federal criminal justice system. However, because of the way the state and federal systems work together, victims of domestic violence and other crimes do not have an easy opportunity to press criminal charges or obtain compensation for their injuries. Instead, victims should consider a civil lawsuit to seek justice for their injuries.

Some people mistakenly believe that victims of rape and other violent crimes are not entitled to compensation because these crimes occur in private homes. Not so! In most states, a victim who has been raped or subjected to serious physical abuse may bring a civil lawsuit against the alleged attacker. Not only are victims entitled to compensation for their injuries, but they may also recover punitive damages in civil court. A rape attorney who has experience in criminal cases will be able to guide you through the process and advise you about your rights.

Once the suspect has been arrested, a criminal case will then be filed against him or her. Even if the suspect is ultimately convicted of committing the crime, victims can still bring a civil lawsuit against them for the damages they suffer as a result of the attack. Even if the charge is dismissed due to lack of evidence, victims may be able to collect damages from the accused. Even if the charge is eventually dismissed, the victim may not be able to permanently eliminate the criminal charges from their record.

Victims of civil suits who are unable to successfully file criminal cases can consult with qualified criminal defense attorneys. Many rape victims find that their assailant committed the crime because they were intoxicated, uninsured or otherwise compromised. In these circumstances, victims can bring civil suits against their attacker even if they are ultimately convicted. If a victim is able to provide proof of the fact that the incident was caused by the victim's negligence, it may make a criminal case against him or her unnecessary.

There are some people who believe that victims of civil suits may choose not to go forward with pursuing a criminal case if they believe that the perpetrator is a student from an educational institution. Students from educational institutions may choose not to hire an attorney if the suspect is from an educational institution. Some colleges and

universities have policies in place to protect students from being accused of sexual assault even when they may not have done anything wrong. The policies may specify that if an individual witness reports that a sexual assault took place, or if a police investigation reveals evidence of a potential case, the school will protect the student from any legal repercussions that may arise from such accusations.

However, if the assault was captured on video and can be played for evidentiary purposes, the victim may be able to press charges in court. This would preclude the accused from denying his or her guilt, but it may also make it difficult for the prosecuting attorney to prove that the victim in fact consented to the sexual act. Some jurisdictions also recognize a right for the victim of civil sexual assault to sue a school for negligence. In these cases, the victim's rights may extend to requiring the school to train its employees to know how to respond to sexual assault and to provide educational opportunities to its students regarding appropriate prevention of sexual assault. If a school allows an employee to remain on the job despite being subjected to a civil lawsuit, it may be liable for monetary damages to the victim.

Vawa is an extremely complex law that requires that victims report their rapes or sexual assaults to law officials and then allow them to participate in a criminal trial. If the victim is able to successfully sue the school for negligence and/or damages, the school may be liable for punitive damages to the victims. Punitive damages are measured based on the emotional pain and suffering of the victim undergoes as a result of the attack, and data may be awarded in order to compensate for past and future medical expenses, mental anguish, loss of wages, pain and suffering, and physical disability. An experienced criminal lawyer can ensure that victims receive just compensation in civil court, while providing important guidance to help victims move forward and avoid future attacks. Lawsuits involving sexual assault can be complex and require expert representation by an experienced attorney.
